# 2. Why the need for state witnesses when the evidence is already clear – By: FPI CE, Dr. Jesus Lim Arranza

IN the ongoing congressional investigations on ghost projects and substandard infrastructure supposedly funded by the Department of Public Works and Highways (DPWH), one question keeps coming up: Do we need state witnesses to pin down the guilty?

Frankly, I think this debate is unnecessary. Why the fuss over state witnesses when the evidence is already staring us in the face?

If a project was allocated funds, documented, and paid for—but never implemented on the ground— then it is not only a ghost project; it is a crime that leaves behind visible emptiness. The absence of a project where one was intended to be built serves as proof—no state witness is needed.

Likewise, if a road, bridge, or flood control structure was supposedly completed but has already crumbled, cracked, or eroded long before its expected lifespan, that's evidence enough. Engineers can measure, test, and certify that the work was substandard. The documents, the site, and the results speak louder than any testimony.

So why should we give those involved an escape route by turning them into state witnesses? If we keep doing this, we only embolden more crooks in government and the private sector—because they know they can always talk their way out later. # 3. Agriculture roadmaps: formulation and implementation - By: Ernesto M. Ordoñez

MANILA, Philippines — For our country, we must not only do things right (eliminate corruption). We must also do the right thing (increase competence). We should do this as we formulate and implement our agriculture roadmaps.

Agriculture Secretary Francisco Tiu Laurel Jr. has already shown unprecedented political will in combating corruption by conducting investigations on 14 Department of Agriculture (DA) officials. In addition, apprehensions of contraband increased fourfold during his watch.

Meanwhile, our agriculture exports increased last year by 22 percent, higher than Vietnam's 18 percent and Thailand's 6 percent. But perhaps because we had suboptimal agriculture export roadmaps and weak direction, our \$7.8-billion exports last year are very low compared to Thailand's \$52.2 billion and Thailand's \$42.2 billion.

### Cacao road map

To improve our agriculture exports, cacao was identified as a promising crop. But without a good roadmap, this promise may not be fulfilled.


On June 26 to June 27, the private sector Philippine Cacao Industry Association, led by Consul Armi Lopez Garcia, worked with the DA and the Department of Trade and Industry for a more effective 2026 to 2028 Philippine Cacao Roadmap. Central to this effort was Edward Barlaan, professor emeritus of the University of Southern Mindanao. Participants were government agencies and cacao stakeholders across the value chain.

Last Oct. 15, they came together to improve and approve the final version of the cacao roadmap. Here are some of its key findings.

As the world races to address climate change, the Department of Labor and Employment (DOLE) is taking steps to ensure that Filipino workers and enterprises are not left behind in the shift to a greener economy.

Through its policy research arm, the Institute for Labor Studies (ILS), and in partnership with the International Labour Organization (ILO), DOLE brought together representatives from government, labor, employers, and civil society in Quezon City for a pre-COP30 consultation on Just Transition, a framework that seeks to balance environmental goals with decent work and social protection.
